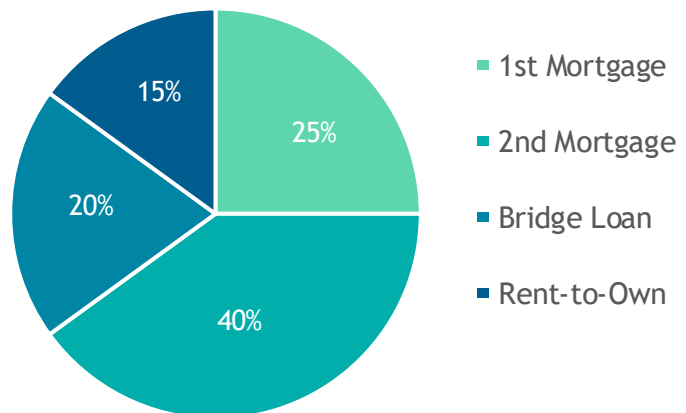

BREAKDOWN

Our investment mix is based on the current market conditions which ensures the highest returns for all investors. RENT-TO-OWN PROCESS

- 1 Identify disgruntled homeowners who are unable to secure a home on their own due to extreme market conditions.
- 2 Sparrow enters into a Rent-to-Own agreement with the homebuyer and assist in financing the down payment.
- 3 The homeowner makes rental payment to Sparrow Invest with a fixed appreciation towards their down payment. The terms and conditions are common across RTO agreements.
- 4 At the end of the RTO term, the homeowner purchases the property from Sparrow based on the predetermined price at the start of the contract

LENDING PROCESS

Pair with industry experts who provide Sparrow with opportunities within the private lending market.

Opportunities are thoroughly assessed using industry-leading practices and professionally licensed individuals which are governed by our EMDs.

We obtain all relevant documentation needed to make an objective investment decision

If the opportunity meets our investment threshold, money is distributed to the borrower and a lien is collected in return of the money provided.

HOW IT WORKS

- 1 Using our partnership with RealShare, the investor can securely create a new account after successfully going through our diligent KYC process.
- 2 The investor is then able to allocate funds into his/her account to make an investment into the fund.
- 3 Once the fund deploys this capital, the returns earned are allocated back to RealShare for proportionate distributions out to the investor.
- 4 Distributions are made to the investor on a quarterly basis in addition to returning the principal amount back to the investor at the end of the investment period.
